PREAMBLE

WHEREAS the Trustees of the Trust has executed the Trust Deed dated 28.11.201114 which has been registered as Document BNG (U)-VRT/324/2011-2012 with pages 1 to 17 in the office of the Sub-Registrar, Varthur, Bangalore.

WHEREAS the Trustees desire to Admit the 4 trustee has executive Trustee and also to amend the trust deed which is required for the purpose of availing certain Exemptions under section 80G of the Income Tax Act 1961 and to register U/s 12AA of the Income Tax Act 1961, which shall now form Part of the Original Clauses of the Trust Deed, as the same were not incorporated in the Registered Trust Deed Dated 28th October 2011. Hence, it is made Compulsory to register this amendment to the Trust deed by admitting the new executive trustee and incorporating the Clauses :

NOW THIS DEED AMENDMENT DEED OF TRUST WITNESSETH AS FOLLOWS:

1. The Name of the Trust shall be called as “ **NALINA SATHEESHA EDUCATION AND CHARITABLE TRUST** ”.
2. **DISSOLUTION CLAUSE:** IN The Event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees of the managing committee/ Government body but the same shall be transferred to another charitable trust whose objects are similar to those of this trust/ society and which enjoys recognition U/s 80G of the Income Tax Act, 1961, as amended from time to time.

3. UTILISATION CLAUSE: The Funds and income of the Trust shall be solely utilized for achievement of the objects of the Trust and no payment shall be made to the trustee by way profit, interest, dividend etc.
4. AMENDMENT CLAUSE:
No Amendments to the trust Deed shall be made which may prove to be repugnant to the provisions of Sec.2 (15),11,12,13,and sec.80 'G' of the I.T. Act,1961 as amendment shall not be carried out without the prior approval of the Commissioner of Income Tax / Director of Income tax (Exemptions). The trustees shall have the power to amend,alter or rescind any of the provisions of the Trust in a manner not consistent with the objects of the Trust.
5. INVESTMENT CLAUSE:
the funds of the trust shall be invested in the modes specified under the provisions of the Section 13(1)(d) read with Section 11 (5) of the Income Tax Act,1961 as amended from time to time.
6. The Trust formed shall be irrevocable.
7. In the event of distributed among the Trustees but the same shall be handed over/ transferred to another trust/Society/Association having objects similar to this Trust and recognized U/S 80 'G' and 12 AA of the Income Tax Act of 1961.
8. The benefits of the trust shall be open to all irrespective of Caste,Creed and Religion.
9. The funds and the Income of the Trust shall be solely utilized for the achievement of its objects and no portion of it shall be utilized for payment to the Trustees by way of profit, Interest, dividends etc.,

All Other clauses of the Trust are un altered and will be continued as going concern for the objectives of the Trust.





